- For applying for the above training, candidates should have studied in the relevant branch/discipline of Engineering from recognized institution as a regular student (full time).
- ❖ Candidates who have passed the relevant qualification in Engineering (BE/B-Tech) from recognized University/Institute from the State of Karnataka alone are eligible to apply.
- Candidates who have undergone Apprenticeship training or job experience for a period of one year or more, after the attainment of the required qualification shall not be eligible to apply.
